**ORDINANCE NO. 90-A**

**AN AMENDMENT TO ORDINANCE 90 OF THE TOWNSHIP OF  
WASHINGTON IMPOSING RESTRICTIONS ON THE MAXIMUM LIMIT OF  
SPEED ON ROADS AND HIGHWAYS UNDER THE JURISDICTION OF THE  
TOWNSHIP OF WASHINGTON AND PROVIDING PENALTIES FOR THE  
VIOLATION THEREOF**

WHEREAS, 75 Pa.C.S.A. §6109 and §3363 authorize local authorities, by Ordinance, to establish a reasonable and safe maximum limit of speed on roads and highways under their jurisdiction; and

WHEREAS, certain roads and highways within the Township of Washington, Westmoreland County, Pennsylvania, already have established thereon certain maximum speed limits and already have erected thereon certain maximum speed limit signs; and

WHEREAS, the Board of Supervisors of the Township of Washington, Westmoreland County, Pennsylvania, desires to establish certain maximum speed limits on roads and highways within the Township of Washington, Westmoreland County, Pennsylvania and to erect maximum speed limit signs on said roads and highways; and

WHEREAS, engineering and traffic investigation studies have been or will be performed and reported to the Board of Supervisors of the Township of Washington, Westmoreland County, Pennsylvania; and

WHEREAS, the Board of Supervisors of the Township of Washington, Westmoreland County, Pennsylvania, deems it in the best interest of the citizens of the Township of Washington and the motoring public to determine and regulate maximum

speed limits permitted on certain roads and highways under their jurisdiction within the Township of Washington, Westmoreland County, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED by the authority of the Board of Supervisors of the Township of Washington, Westmoreland County, Pennsylvania, and it is hereby RESOLVED AND ORDAINED by the authority of the same as follows:

SECTION 1. The Board of Supervisors, on motion duly made and passed at a duly advertised public meeting, a quorum being present, based upon the performance of the engineering and traffic studies as required by the Pennsylvania Motor Vehicle Code may from time to time establish maximum speed limits for roads and highways under the jurisdiction of the Township of Washington, Westmoreland County, Pennsylvania, and authorize the Chief of Police to purchase and erect maximum speed limit signs on said roads and highways.

SECTION 2. The maximum speed limits as established in Section 1 of Ordinance 90 shall continue in full force and effect unless amended in accordance with the procedures as set forth in this Ordinance.

SECTION 3. If the Board of Supervisors establishes a maximum speed limit on a previously-unregulated road or highway within the jurisdiction of the Township of Washington, Westmoreland County, Pennsylvania, or if the maximum speed limit of a road or highway previously established by Ordinance 90, Section 1, is altered, then the Secretary of the Township of Washington shall cause a certified copy of the minutes of said public meeting at which the foregoing occurred to be placed on file with Ordinance 90 and this Ordinance, along with the engineering and traffic study regarding said road or



highway within the jurisdiction of the Township of Washington, Westmoreland County, Pennsylvania.

SECTION 4. The Board of Supervisors of the Township of Washington, Westmoreland County, Pennsylvania, has elected to adopt this procedure to avoid the time, expense and delay associated with passing an Ordinance each and every time the Board of Supervisors determines, on the basis of an engineering traffic study, that a road or highway within the jurisdiction of the Township of Washington, Westmoreland County, Pennsylvania, shall have a maximum speed limit established thereon.

SECTION 5. Effective Date – This Ordinance shall take effect in five days.




AN ORDINANCE ESTABLISHING MAXIMUM SPEED LIMITS ON CERTAIN ROADS WITHIN WASHINGTON TOWNSHIP, WESTMORELAND COUNTY, PENNSYLVANIA AND SPECIFICALLY AMENDING SPEED LIMIT ON NORTH WASHINGTON ROAD

BE IT ORDAINED, by the Board of Supervisors of the Township of Washington, County of Westmoreland, Commonwealth of Pennsylvania, and it is hereby ordained and enacted by the authority of the same that the speed limit as set forth in Section 1 for North Washington Road from West LR 69 to LR 348 be amended by changing the speed limit thereon from 25 MPH to 35 MPH.


All of the remaining terms and conditions of Ordinance 90 shall remain in full force and effect and are not altered, changed, revoked or modified by virtue of this amendment.



AN ORDINANCE ESTABLISHING MAXIMUM SPEED LIMITS ON CERTAIN  
ROADS WITHIN WASHINGTON TOWNSHIP, WESTMORELAND COUNTY,  
PENNSYLVANIA

WHEREAS, the Pennsylvania Motor Vehicle Code, Purdons Title  
75, §6109 and §3363 authorize local municipalities, by ordinance,  
to establish a reasonable and safe maximum limit of speed on roads  
and highways under their jurisdiction; and

WHEREAS, certain roads and highways within Washington  
Township, Westmoreland County, Pennsylvania already have erected  
thereon certain maximum speed limit signs; and

WHEREAS, the Board of Supervisors of Washington Township,  
Westmoreland County, Pennsylvania desire to erect certain maximum  
speed limit signs on other presently unregulated roads and highways  
within Washington Township, Westmoreland County, Pennsylvania; and

WHEREAS, engineering and traffic investigation studies have  
been performed and reported to the Board of Supervisors of  
Washington Township, Westmoreland County, Pennsylvania; and

WHEREAS, the Board of Supervisors of Washington Township,  
Westmoreland County, Pennsylvania deem it in the best interests of

the citizens of Washington Township and the motoring public to determine and regulate maximum speed limits permitted on certain roads and highways under their jurisdiction within Washington Township, Westmoreland County, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED and ORDAINED by the authority of the Board of Supervisors of Washington Township, Westmoreland County, Pennsylvania and is hereby RESOLVED and ORDAINED by the authority of the same as follows:

Section 1. Maximum speed limits are hereby established on the following Township roads and highways:

Section 2. Fines and Penalties shall be determined, calculated and imposed in accordance with the applicable Motor Vehicle Code and PennDot rules and regulations for determining fines and penalties for speeding on highways under PennDot jurisdiction and any person who shall exceed the established maximum speed on any road or highway in violation of the provisions of this Ordinance shall, upon conviction thereof before a District Magistrate, be sentenced to pay the fine and costs thus determined, calculated and imposed and, in default of payment of such fine and



costs, be imprisoned in the Westmoreland County Detention Center for a period of not more than ten (10) days.
