**ORDINANCE NO. 129**

**AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON  
REPEALING ORDINANCE NO. 22, ORDINANCE NO. 44,  
ORDINANCE NO. 47, ORDINANCE NO. 48,  
SECTION 10 OF ORDINANCE NO. 122, AND THE FIRST SENTENCE  
OF ORDINANCE NO. 100, SECTION 519(a); PROVIDING THAT  
ALL RULES, REGULATIONS, PROCEDURES, MANDATES,  
REQUIREMENTS, FEES, CHARGES, COSTS AND EXPENSES  
RELATING TO PUBLIC SANITARY SEWERS WITHIN THE  
JURISDICTIONAL BOUNDARIES OF THE TOWNSHIP OF  
WASHINGTON BE REFERRED TO THE MUNICIPAL AUTHORITY  
OF WASHINGTON TOWNSHIP FOR ADMINISTRATION,  
IMPLEMENTATION AND ENFORCEMENT**

WHEREAS, the Township of Washington Board of Supervisors by Ordinance No. 110 created the Municipal Authority of Washington Township (MAWT) pursuant to the Municipal Authorities Act of 1945, as amended, for the purposes as set forth therein; and

WHEREAS, prior to the formation of MAWT, certain geographical areas of the Township of Washington were already served by public sanitary sewers; and

WHEREAS, because there were certain geographical parts of the Township of Washington served by public sanitary sewers prior to the formation of MAWT, the Township of Washington, from time to time, passed ordinances providing rules and regulations concerning, inter alia, properties effected by the availability of public sanitary sewers; and

WHEREAS, in order to eliminate confusion, the Township of Washington deems it to be in the best interests of the Township, MAWT and its citizens that most of the ordinances passed

by the Township of Washington dealing with public sanitary sewers be repealed and that the jurisdiction of such issues relating to public sanitary sewers be deferred to MAWT.

NOW, THEREFORE, be it ordained and enacted by the Board of Supervisors of the Township of Washington, and it is hereby ordained and enacted by the authority of the same as follows:

SECTION 1: Ordinance Nos. 22, 44, 47, 48, Section 10 of Ordinance No. 122, and the first sentence of Ordinance No. 100, Section 519(a) are hereby repealed in their entirety.

SECTION 2: Ordinance No. 110 and the remaining provisions of Ordinances 122 and 100 are not repealed.

SECTION 3: The Municipal Authority of Washington Township is hereby recognized as the predominant authority for the purpose of constructing, maintaining, operating, acquiring, holding, financing, improving, owning and leasing public sanitary sewers, public sanitary sewer systems, parts thereof, sewage treatment works, including works for treating and disposing of industrial waste and related products and related projects; to further adopt all rules, regulations, policies, procedures and mandates in connection with the foregoing; to determine all fees and charges in any way relating to the foregoing; to enforce the provisions thereof, and to otherwise generally exercise any and all powers granted under the Municipal Authorities Act of 2001, as amended.

SECTION 4: Nothing in this Ordinance shall be deemed to prohibit, prevent or limit the powers granted to the Township of Washington under the laws, rules and regulations of the

Commonwealth of Pennsylvania to transact in the matters as set forth in Section 3 hereof in the event the Township of Washington deems it necessary and appropriate to do same.

SECTION 5: The effective date of this Ordinance shall be the 9th day of May, 2003.
